**Product Applications:** **Crystal Series 305** provides crisp, white ambient/accent light in a uniquely counter-balanced pendant light design, with matching wall sconce models.

Units are suited for use as accent or ambient lighting in a wide range of commercial or higher-end residential installations. These include art galleries; merchandise showrooms; hospitality venues; upscale retail; building entryways, lobbies and corridors; executive suites and conference rooms; professional offices; residential bathrooms and vanities. Units can be grouped to form repeating patterns of suspended and wall lighting designs.

**Product Description:** **Crystal Series 305** counter-balanced pendants present a series of 3-, 4- or 5-light modules reminiscent drum-shaped crystalline goblets. Each low-voltage light unit is mounted inverted to a horizontal light bar.

Above the light bar is a secondary bar that serves as a counter-balancing mechanism to prevent swaying or twisting of the pendant.

Both bars are suspended from a rectangular ceiling rise by a pair of individual aircraft cables. One- or two-uplight low-voltage wall sconces complement the pendant downlight models.

**Construction & Finishes:** Pendant light bar, counter-balance bar and ceiling rise are chrome-plated steel. Wall sconces are mounted to chromed steel back plates, with matching short stems and light arms.

Glass crystal shades may be ordered in amethyst, cobalt blue or diffused clear crystal.

Each **Crystal Series 305** model employs 12-volt 35-watt Xenon lamps.
